### IT IS UNDERSTOOD AND AGREED THAT:

1. The undersigned acknowledges Bids are required for the entire work. The amount of the bid for comparison purposes will be the total of all Bid Schedules. The estimated quantities for unit price items are for purposes of comparing bids only and the City makes no representation that the actual quantities of Work performed will not vary from the estimates. Furthermore, the quantities shown on the Bid Schedule are approximate only. They are listed as a general indication of the amount of work to be performed or materials to be furnished. Final payment shall be determined by the Engineer from measured quantities of Work performed based upon the unit price. The Contractor will be paid for the actual quantities of work completed based on field measurements.
2. The undersigned acknowledges that the City reserves the right to increase or decrease the amount of any item or portion of work to be performed or material furnished, or to delete any item, in accordance with the Specifications and Special Provisions.
3. The undersigned has carefully examined all the Contract Documents which will form a part of the construction Contract and all additions, deletions, modifications, appendices, and all addenda as prepared prior to the date of bid opening setting forth any modifications or interpretations of said documents acknowledged as follows:

7. This Bid Proposal shall be good and shall not be modified, withdrawn, or cancelled by the undersigned for a period of ninety (90) calendar days after the City's opening of bids; and

The undersigned will execute the Contract and furnish the required Performance and Payment Bonds, a City business license, and proof of the required insurance coverage and endorsements within ten (10) Business Days after notice to him/her of acceptance of his bid by the City, and failure to do so shall result in a forfeiture of the Bid Guaranty to the City; and
9. The undersigned hereby certifies that all items listed below are checked, fully completed, executed, and hereby submitted with this Bid Proposal. By checking each item listed below the undersigned certifies that he/she understands that failure to complete and/or submit any of the required documents may be cause for rejection of his/her Bid Proposal.
